These Terms and Conditions apply to all memberships and services provided by Pocket Maths Tutor.

By purchasing a membership or accessing services, you confirm that you have read and agree to Pocket Maths Tutor's policies, including the Privacy Policy, Safeguarding Policy, Complaints Policy, and Code of Conduct.

Membership Model

Pocket Maths Tutor operates a monthly subscription-based membership. Membership provides access to weekly drop-in sessions, Pocket Support, and learning resources during term time, in accordance with the selected membership tier.

Membership is for the named student only.

Session Access

Students may attend any drop-in sessions offered as part of the programme. Sessions are curriculum-led and designed to support learning but are not personalised one-to-one lessons.

Pocket Maths Tutor reserves the right to amend session times or formats where necessary, with reasonable notice.

Pocket Support

Pocket Support is intended for short clarification and guidance. Support is limited to two contacts per day during term time and is not a substitute for full tuition.

Optional 1:1 Tuition

One-to-one sessions are available as an optional paid add-on and are subject to availability. Separate booking and payment terms may apply.

Payments

All payments are processed securely via Stripe. Membership fees are charged monthly in advance and renew automatically unless cancelled in accordance with these Terms.

You are responsible for ensuring payment details remain up to date.

Cancellation and Refunds

Membership may be cancelled at any time. If a cancellation is made after a monthly payment has been taken, access will continue until the end of the paid billing period.

No refunds or credits are provided for unused time within a paid billing period, except where required by law.

Acceptable Use and Account Sharing

Membership access is for the named student only. Account sharing is not permitted.

Pocket Maths Tutor reserves the right to suspend or terminate access where account sharing, misuse, or unauthorised access is detected.
